Insurance for loss incurred by the insured due to recharacterization of a transaction resulting in the clawback of amounts paid or imputation of a third party’s liabilities to the insured.

### **DISCLOSUREGAP® Warranty & Indemnity Insurance**

Insurance for loss incurred by the insured as the result of the breach or inaccuracy of warranties and indemnities made in a transaction agreement.

### **FISCALGAP® Tax Deed Replacement**

Insurance for pre-closing tax liabilities of the target company not provided for in the target’s financial statements and not known to the buyer at the time of the transaction closing.

### **INTERPRETATIONGAP® Tax Insurance**

Insurance for loss incurred by the insured as the result of one or more tax positions or tax treatments being challenged and disallowed by the relevant tax authority.

### **LIQUIDATIONGAP® Policy for Private Investment Funds**

Insurance for loss caused by identified or unknown potential exposures, whether contractual or otherwise, that do not fully develop until after the date that the insured liquidates.

### **Specific Contingency Insurance**

Insurance for loss incurred by the insured due to the crystallisation of an administrative, judicial, or legislative exposure or unintended interpretation of a contractual provision.
